## MESSAGE TO THE FEDERAL PERSONNEL COMMUNITY AND MANAGERS:

We are at the beginning of an important and exciting journey. The first step along this journey was taken by the National Performance Review (NPR). Their recently released report identified the root problem of the Federal Government as the way we do our business, specifically, our tendency to generate red tape and pay too little attention to results.


The Federal Personnel Manual (FPM), which was originally designed to provide operational guidance and advice, exemplifies the problem. Over the years, it has become highly complex, detailed, and laden with process requirements. The NPR recommendation to abolish the 10,000 page FPM is intended to give you, the personnelist or manager, greater flexibilities to manage your human resources and meet your agency's mission.

With this document, we are taking the second step of the reinvention journey by implementing the NPR recommendation to abolish the FPM. The Office of Personnel Management (OPM) worked very closely with all the stakeholders to identify those parts of the FPM that are essential and do not duplicate law or regulation. Only essential information is being provisionally retained. The planned "sunset" of the FPM will make it possible, at the agency level, to change certain personnel policies and practices. In the interest of stability and dispute prevention, the National Partnership Council urges agencies and unions to refrain from pursuing these changes for six months from the effective date of the FPM Sunset, unless mutually agreeable.

What does this mean to you, Federal employee, personnel specialist, or manager? Think of this document as a sunset to some of the frustrations, anxieties, and constraints of doing your work today. It is also the sunrise of possibilities which empower you to perform your job without unnecessary constraints. The abolishment of the FPM will not relieve you of the obligations mandated by law or regulation. However, it will give you more flexibility and authority to design those systems which work best for your agency in the fulfillment of your mission.

I challenge you to be a leader in reinventing your agency's personnel systems. OPM stands ready to work with you to transform the old process oriented methods into results oriented systems that meet the needs of you, our customers. We look forward to our successful partnership, and welcome the opportunities for change in the future.

## INTRODUCTION

Effective December 31, 1993, the Federal Personnel Manual (FPM) is abolished. It is succeeded by a Provisional System which will sunset on December 31, 1994. The Provisional System has three parts which are explained in this document. They are:

### Specifically Retained Provisions of the FPM

*These provisions have been retained to avoid policy gaps and continue the smooth functioning of the Government. During 1994, this material will be incorporated into other documents as appropriate. The retained provisions, as well as abolished material, are detailed in the Summary Table and Chapter Summary Sheets (pages 5-101).*

### Notice and Posting System

*This system has been set up to provide a vehicle for OPM to communicate with operating personnel offices. During 1994, OPM will also post information on electronic bulletin boards and other alternative media. The provisional Notice and Posting System is covered on page 102.*

### Operating Manuals

*Those parts of the FPM that deal with the uniform processing of employment actions and retirement and insurance matters are replaced by Operating Manuals. These manuals will be reauthorized during 1994, and will continue after the sunset date. The Operating Manuals are covered on page 103.*

### For Assistance

Throughout the Sunset Document, the telephone numbers of subject matter experts who can answer your questions are provided (see numbers listed on the bottom of each Chapter Summary Sheet). The Sunset Document and other relevant information is also available on the OPM Mainstreet Bulletin Board (202-606-4800). For assistance regarding the Notice and Posting System, please contact the OPM Issuance Office on (202) 606-1973. In our new role as an advisor and consultant, we are prepared to work with you to create effective, agency specific personnel systems that fit your unique needs.

## HOW TO USE THIS DOCUMENT

The Federal Personnel Manual (FPM) Sunset Document outlines the FPM material that is abolished and the FPM material that is being provisionally retained through December 31, 1994. It also contains information on the provisional Notice and Posting System and information about covers for the new Operating Manuals.

### SUMMARY TABLE AND SUBJECT AREA SUMMARY SHEETS

The **Summary Table** is in numerical order by FPM chapter, and may be used as a quick reference to determine the disposition of all material in any FPM subject area.

The **Chapter Summary Sheets** are also in numerical order by FPM chapter. Each summary sheet outlines the status of all information currently in the FPM for a specific chapter, including all subchapters, appendices, letters, bulletins, and supplements. The Summary Sheets are hole punched so that they may be placed in the front of the corresponding current FPM chapter for easy reference.

**Each summary sheet is divided into the following sections:**

#### ABOLISHED

Material that is eliminated from the FPM because it is redundant, out-of-date guidance, advice, or unnecessary regulation.

#### PROVISIONALLY RETAINED THROUGH DEC. 31, 1994

Material that is being retained because it contains process instructions, critical case law, ensures consistency of action throughout Government, or authorizes agency action. After December 31, 1994, this information will either be issued as process manuals, delegated to agencies, or incorporated into regulation. If all material in a FPM chapter has been abolished, there will be no section on provisionally retained material.

Within the Abolished and Provisionally Retained sections of the Chapter Summary Sheets, each chapter is separated into subchapters, appendices, letters, bulletins, and supplements. Disposition of information is then identified using the following terms:

- **ALL**  
When all information in a specific section of the chapter is being abolished.
- **NONE**  
Used in tandem with "All." For example, if all of the subchapters are abolished, none is being provisionally retained.
- **NONE EXIST**  
Indicates that there is no existing information in that section or title of the FPM chapter.
- **ALL, EXCEPT AS NOTED IN THE RETAINED SECTION**  
Only the material that is specifically noted is being retained, the rest (if any) is abolished.

**RELEVANT STATUTORY AND OTHER REQUIREMENTS:**

This section provides the statutory and/or other cites that the information in a FPM chapter is based on. The following abbreviations are used in this section: U.S.C. for United States Code; CFR for Code of Federal Regulations; E.O. for Executive Order; and § for Sections of the U.S.C.

**CONTACT(S):**

This section provides the name and phone number of an office within OPM that will answer questions, provide advice, and offer assistance to users of the Sunset Document.

**NOTICE AND POSTING SYSTEM**

During calendar year 1994, the current FPM distribution system will be kept in place. Under a provisional notice and posting system, current subscribers will continue to receive notices on regulations; variations; pay levels and other adjustments to pay or annuities; changes to current operating requirements; and Governmentwide policy information. Refer to the section of this document on the notice and posting system for further information.

**OPM OPERATING MANUALS**

Several of the current Supplements contain procedural guidance that is applicable to all agencies. These supplements are replaced by operating manuals. During calendar year 1994, the operating manuals may have updates similar to the current installments. Any

updates that are issued during the provisional year will be distributed to those subscribers who currently receive the supplements. The covers for these new manuals are included at the end of the Sunset Document. Please refer to the section of this document on operating manuals for further information.

### **POST FPM ENVIRONMENT**

Over the next year, the Office of Personnel Management will be exploring different options and testing alternative formats for communicating personnel information. All current subscribers will be kept up-to-date regarding innovations and future technology.

### **ADVICE FROM THE NATIONAL PARTNERSHIP COUNCIL**

The planned "sunset" of the Federal Personnel Manual will make it possible to change at the agency level certain personnel policies and practices that the FPM had mandated or prescribed. In the interest of stability and dispute prevention, the National Partnership Council (NPC) urges agencies and unions to refrain from pursuing such changes, unless they are mutually agreeable to both parties, for six months from the effective date of the FPM sunset. In other words, the NPC asks both unions and agencies to refrain from pursuing changes that will result in a dispute and require a third party to resolve. This six month moratorium on other than mutually agreeable changes will enable agencies and unions to jointly assess the extent of changes made possible by the FPM sunset and to approach making changes in a partnership manner.

### **HELPFUL HINTS FOR USERS**

- Supplements have been listed with the appropriate chapter, i.e. information on Supplement 296-33 can be found on the Chapter Summary Sheet for Chapter 296.
- All provisionally retained material is specifically listed. If you do not see it listed, it is abolished!
- Bulletins that have been provisionally retained expire on the date shown on the bulletins, not on December 31, 1994.
- The new operating manuals will be reauthorized before December 31, 1994. During 1994, you will continue to receive notices (similar to current installments) updating these manuals.

**NOTICE AND POSTING SYSTEM**

Under the provisional system, the Office of Personnel Management will continue to communicate with agency operating personnel offices using a "Notice and Posting System." This system will provide a vehicle for OPM to quickly communicate important and essential information at the operating level. The Notice and Posting System will replace FPM bulletins. The current FPM distribution system will remain in place during the provisional period, and the new notices will follow that pattern. For example, those subscribers who are to receive all information issued under FPM subject area 591, will receive notices that pertain to that subject area. The only function of notices under the provisional system is to transmit information, and as such they will not have an expiration line. However, the material transmitted will contain appropriate information regarding its relevancy. For example, a "Notice of OPM Regulatory Change" will include instructions to post a proposed or final regulation for a specific period of time. The new notice and posting system will be limited to four types of notices:

- Notice of OPM Regulatory Change

*These notices will transmit for posting OPM proposed and final regulations.*

- Notice of OPM Variations

*These notices will transmit information on the variations that were permitted by OPM over specific period of time.*

- Notice of OPM Operating Information

*These notices will transmit information on new pay levels, cost of living adjustments, changes in processing codes, etc., that will be incorporated into other operating documents; e.g., one of the continuing operating manuals or the Federal Pay Table.*

*Changes to current operating requirements are usually the result of changes in law or Executive order. Occasionally they derive from court and third party decisions.*

- Notice of OPM Policy Information

*These notices will transmit information regarding Presidential and Administration policy. They will also transmit special announcements and policy statements.*


