Central Personnel Data Files (CPDF) September Files and the December 1, 2004 Annuity Roll

The Central Personnel Data File (CPDF) is an automated information system containing individual records for most Federal civilian employees. The information is covered by the Privacy Act of 1974. The CPDF covers all Federal civilian employees of the Executive Branch, with the exception of those in the Central Intelligence Agency, Defense Intelligence Agency, Federal Reserve System (Board of Governors), National Security Agency, Defense Imagery and Mapping Agency, Office of the Vice President, Tennessee Valley Authority, U.S. Postal Service, Postal Rate

Commission, and the White House Office. Citizens of other countries who are working for the United States in foreign countries, most non-appropriated fund personnel, commissioned officers in the Department of Health and Human Services, Department of Commerce and Environmental Protection Agency, and all employees of the Judicial Branch are also excluded. Legislative Branch coverage is limited to the Government Printing Office, U.S. Tax Court and several small commissions. This data is prepared by the Office of Personnel Management, Workforce Information & Planning Group from the Central Personnel Data File.

The Annuity Role includes Federal employee annuitants and survivor annuitants receiving Civil Service Retirement System (CSRS) or Federal Employee Retirement System (FERS) annuities. This data is prepared by the Office of Personnel Management, Retirement Services Programs from the December 17, 2004 Annuity Roll Address File. Data includes interim pay cases.
