*THE FACT BOOK* is produced annually by the U.S. Office of Personnel Management (OPM) as a convenient reference suitable for a variety of audiences. It contains descriptive statistical information, using tables and charts, about many aspects of the Executive Branch workforce. **Note that data for the U.S. Postal Service are excluded from all tables except those on pages 8 and 64, and the tables in Part 4.** Both historical and current data are displayed, resulting in a comprehensive snapshot of the Federal worker -- personal and professional characteristics, employment levels, and benefit payments and contributions. The statistical tables and charts in *THE FACT BOOK* are based on data from a wide range of sources, each of which is cited on the appropriate page with telephone contacts and email addresses if available.



## The "Typical" Federal Civilian Employee, 2005 Individual Characteristics












## Average Adjusted Basic Salaries and Full-Time Employment by State (10 Lowest Only)









## Average Grade Trend for General Schedule Employees All Areas, Full-Time Only (1974 - 2005)





Executive Branch Employment By General Schedule (GS) and Related Grades, 2001 - 2005

































## Senior Executive Service (SES) Positions and Appointments






Allocated vs Appointed





**Career vs Non-Career** 












## Federal Employee Health Benefits Program




















