## THE DOD/FEHBP DEMONSTRATION PROJECT MAY BE FOR YOU!

The Open Season for enrollment in the DoD/Federal Employees Health Benefits Program (FEHBP) Demonstration Project recently closed. We are concerned that many of you who were eligible to enroll have not explored this opportunity.

While this program is not for everybody, if you have Medicare, FEHB benefits combined with your Medicare coverage can provide important additional health care coverage at reasonable cost. For example, if you now have Medicare Parts A and B, and you join one of the fee-for-service plans offered through the FEHBP, you can usually get first dollar coverage (that is, with all deductibles and coinsurance waived) for all your non-prescription medical care provided by the plan. And you'll pay only the deductible and coinsurance for prescription drugs. The enclosed flyer gives more details and answers some of the questions you may have.

DoD contributes a substantial portion of the premium cost for this coverage. You pay only the difference between the DoD contribution and the total premium.

If you think you might be interested in participating in this demonstration project, it's not too late. If you contact us at 1-877-DOD-FEHB (1-877-363-3342) within 30 days from the date you receive this letter, we will send you information on participating plans and an application for enrollment. You'll then have 30 days to make a decision.

But don't delay. If you decide to enroll, it will be effective January 1, 2000, regardless of when we receive your application. That means you must pay a premium for the entire month of January. However, if you received covered health care services, you can submit claims for reimbursement. If you join an HMO, the care you received must have been from a plan provider.
