Subject: Fall Conference Registration and Synopsis

The Office of Personnel Management (OPM) and the American Association of Health Plans (AAHP) are once again collaborating on a conference to address program-wide as well as HMO and fee-for-service plan specific issues under the Federal Employees Health Benefits (FEHB) Program. Please read the following information carefully for important details. We encourage all FEHB carriers to attend.

October 16, 2000:

We have scheduled a special pre-conference meeting for the afternoon of Monday, **October 16, 2000,** at the Office of Personnel Management (1900 E Street, NW, Washington, DC 20415).

This will be a joint meeting for health plan and Employee Assistance Program (EAP) administrators. We urge you to be represented at this meeting. As we draw closer to mental health and substance abuse parity implementation in 2001, it is important that key participants have the chance to meet each other and discuss processes.
