### **Program-wide changes**

- In Section 9, we revised the **Medicare Primary Payer Chart** and updated the language regarding Medicare Advantage plans (formerly called Medicare + Choice plans).
- In Section 12, we revised the language regarding the Flexible Spending Account Program - *FSAFEDS* and the Federal Long Term Care Insurance Program.

### **Changes to this Plan**

- Your share of the non-Postal premium will increase by .8% for Self Only or .8% for Self and Family.
- You may now select your specialist from our HMO Choice Provider network. You are no longer required to see a specialist selected by your primary care physician.
