Subject: Federal Employees Health Benefits Program Open Season - Introduction

DATES	The 1997 Federal Employees Health Benefits (FEHB) Program open season will be held from November 10 through December 8, 1997.
BALs	As we proceed with our preparations for the 1997 open season, this introductory BAL (Benefits Administration Letter) will be followed by a series of BALs designed to give you information about ordering open season materials, significant FEHB plan changes for 1998, suggested open season notices for your employees, and other useful information that will enable you to conduct a successful open season at your agency.
EMAIL HOTLINE	The telephone open season hotline used during the past several open seasons has been replaced this year with an Internet email hotline.

Purpose	The email Hotline will enable us to answer agencies' open season questions quickly and efficiently. #### ADDITIONAL INFORMATION ABOUT THE 1997 OPEN SEASON

#### **FEHB Guides**

There will be no changes in the quantity of RI 70-1, the FEHB Guide used by most employees, for the 1997 open season. The same quantity that was printed for the 1996 open season -- an amount equal to 60% of an agency's population -- will be printed for this year's open season.

#### **Audio Cassettes**

OPM will not be involved in the ordering of audio cassette tapes for the visually impaired. Agencies must order these tapes directly from the open fee-for-service plans. We will include the list of plan contacts from whom you may order the tapes when we send you the BAL on ordering and distribution (sometime in late August).

## OPM Web Site and OPM ONLINE

The 1998 FEHB Guide (RI 70-1), all health plan brochures, and the News Release announcing the 1998 rates will be uploaded to OPM's Web site < http://www.opm.gov/insure> and OPM ONLINE (202-606-4800). The FEHB Guide and each brochure will be available in PDF format for downloading and printing, as well as WordPerfect 5.1 suitable for the visually impaired.

In addition, the Web site will contain a version of the FEHB Guide designed specifically for the electronic environment. It will contain links from plans' names to the plans' brochures, in both formats. It will also contain links from the FEHB Guide and the brochures to plan Web sites for additional information about the plan, and links to other Web sites.
