Subject: Changes to Federal Employees Retirement System (FERS) Contribution Rates for Fiscal Year 2016

At its 2013 meeting, the Board of Actuaries of the Civil Service Retirement System recommended revised economic assumptions for use in actuarial valuations of the Federal Employees Retirement System (FERS). These revised assumptions result in new normal cost percentages that will increase the employer contributions that agencies pay for FERS employees.

New employer contribution rates will become effective with the first pay period beginning on or after October 1, 2015.
