Subject: Changes to Agency Contributions for the Federal Employees Retirement System

This letter provides notice of the revised normal cost percentages for employees covered by the Federal Employee Retirement System (FERS) Act of 1986. The revised normal cost percentages, as described in the enclosed tables, are effective at the beginning of the first pay period commencing on or after October 1, 2023, and affect agencies' contribution rates for FERS employees, FERS-Revised Annuity Employees (FERS-RAE) and FERS-Further Revised Annuity Employees (FERS-FRAE). Agency appeals of the normal cost percentages must be filed no later than **October 16, 2023**.
