**Subject: 1997 Federal Employees Health Benefits (FEHB) Program Open Season:
Significant Plan Changes**

PURPOSE

This letter transmits lists of significant events affecting certain health plans during the upcoming FEHB open season. Please note that some of these events will require action on the part of agencies and enrollees.

TERMINATIONS

Attachment 1: Plans Dropping Out of FEHB for 1998

Attachment 2: Plans Reducing Their Service Areas by Terminating an Enrollment Code

1. **What must employees do?** Employees in these terminating plans/codes **must** choose a new health plan during open season. Employees who do not choose a new health plan will be considered to have cancelled their coverage and will not have health benefits for 1998.
2. **New Coverage.** Coverage under an enrollee's new health plan will be effective the first day of the first pay period beginning on or after January 1, 1998; for most employees this will be January 4. Enrollees will remain covered and receive benefits under the old plan until coverage under the new plan becomes effective.
3. **Plan Notification.** The plans in Attachments 1 and 2 are supposed to notify their enrollees of the need to select a new health plan for 1998. However, some plans' enrollment and address lists may not be up to date.
4. **What must agencies do?** Agencies must notify employees in these terminating plans and enrollment codes of the need to select a new health plan to avoid losing coverage. This is especially important since many employees will not receive a copy

of the FEHB Guide and will therefore be unable to check the comparison chart to see if their plan will still be participating in 1998.

We strongly recommend that you notify your employees by distributing copies of these lists to each employee, along with your agency's notice to employees about open season.

We also recommend that, before the end of open season, you follow up with employees in these plans who have not made a new election and remind them to select a new health plan.

5. **Belated Changes.** Despite these precautions, there are likely to be some employees who do not get the word to change plans during open season. We encourage you to be liberal in using your authority to accept belated open season changes from employees enrolled in a terminating health plan/enrollment code.

SERVICE AREA REDUCTIONS

Attachment 3: Plans Significantly Reducing Their Service Area Without Terminating an Enrollment Code

Enrollees in the service areas being terminated should consider choosing a new plan for 1998. Enrollees who do not choose a new plan during open season will have to travel to the plan's remaining service area to obtain medical care in order to receive full benefits from the plan.

Attachment 4: Partial Service Area Transfers

Attachment 5: Plans Splitting a Service Area

Enrollees in plans covered by Attachments 4 and 5 should consider changing their code (or plan) during open season. Otherwise they will have to travel to the area served by their enrollment code to obtain medical care to receive full benefits from the plan.

Agency Action Required. You may wish to distribute a copy of this list to each employee, along with your agency's notice to employees about open season. If you don't distribute the list, remind employees to check their new health plan brochures carefully to see if there have been any changes to their plans' service areas that will affect them.

OTHER SERVICE AREA CHANGES

Attachment 6: Service Area Consolidations

These plans are consolidating service areas; i.e., changing from two or more enrollment areas to one. The service areas will remain the same, but they will be included under one enrollment code. Enrollees in the "departing" enrollment codes will be transferred automatically to the remaining enrollment code.

Attachment 10: Plan Mergers

Any enrollees in the old plans who do not wish to be transferred to the new plan must choose a different plan during open season.
2. Please note that, in addition to merging, the Aetna and US Healthcare plans are changing their name to Aetna US Healthcare.
