### **Subject: 2015 Federal Benefits Open Season: Ordering and Distributing Materials**

This Benefits Administration Letter (BAL) is the second in our series of 2015 Federal Benefits Open Season BALs. This BAL (15-402) provides instructions for ordering and distributing Open Season materials including program-specific materials for the Federal Flexible Spending Account Program (FSAFEDS), Federal Employees Dental and Vision Insurance Program (FEDVIP), and Federal Employees Health Benefits (FEHB) Program. Please be aware that it is now too late to order FEHB Fee-for-Service (FFS) health plan brochures. If you did not order a supply of FFS health plan brochures, you can access these brochures at [www.opm.gov/FEHBbrochures](http://www.opm.gov/FEHBbrochures).

You can request HMO plan brochures directly from the health plan contacts identified in Attachment 4, FEHB Plan Contacts for Requesting HMO Brochures.

Please distribute Attachment 1, Going Green – View Your FEHB Brochure Online or Contact Your Plan for a Paper Brochure, to your employees.

We previously described our continuing Going Green initiative in BAL 15-401. This effort has a two-fold purpose:

- 1) to provide employees the option of viewing brochures online or to receive a paper copy of their health plan's brochure; and
- 2) to limit the number of brochures printed and distributed to Federal agencies.

We believe that coordination between agency headquarters and field offices should produce a much lower need for paper brochures and yet still ensure that those sites that need paper brochures will have them.

Please carefully review Attachment 2, Easy to Use Chart for Ordering and Distributing Materials for FSAFEDS, FEDVIP, and FEHB. We would also like to remind you of the following materials that we included last year:

- 1) Federal Benefits Open Season flyers and banners – post these around your offices to remind employees about the Federal Benefits Open Season;
- 2) Insurance Benefits Flyers – one-page summaries of the insurance benefits of the Federal Benefits Programs (FSAFEDS, FEDVIP dental, FEDVIP vision, FEHB Program, Federal Employees' Group Life Insurance (FEGLI) Program, and Federal Long Term Care Insurance Program (FLTCIP); and
- 3) Save Money On...Flyers – these flyers show how FSAFEDS, FEDVIP, and FEHB work together to save employees money.

This year's Federal Benefits Open Season will run from Monday, November 9 through Monday, December 14, 2015.

As a reminder, the Federal Employees' Group Life Insurance (FEGLI) Program and the Federal Long Term Care Insurance Program (FLTCIP) **do not** participate in the annual Federal Benefits Open Season.
