

**Taxpayer-Funded Union Time
Usage in the
Federal Government
Fiscal Year 2024**

Introduction

President Trump has promised to restore efficiency and accountability in the Federal Government. Doing so is crucial to improve the ability of agencies to deliver mission outcomes, provide excellent service, and effectively steward taxpayer dollars. In support of this important effort, and to meet the needs and expectations of agencies, employees, and the ultimate customers – the American people – it is necessary to evaluate the cost of granting and using taxpayer-funded union time by Federal employees for labor-management relations activities. This Governmentwide report on the use of taxpayer-funded union time and other government resources for Federal employees representing labor organizations promotes transparency, accountability, and good stewardship for the American taxpayers.

Taxpayer-Funded Union Time

The Federal Service Labor-Management Relations Statute (Statute)¹ establishes the collective bargaining system in the Federal Government. The Statute further specifies that its provisions should be interpreted “in a manner consistent with the requirements of an effective and efficient Government.”² In any case, some provisions of the Statute result in considerable costs to the Government and taxpayers, such as matters involving official time, referenced here as “taxpayer-funded union time” or “TFUT,” without any comprehensive evidence that these provisions support an effective and efficient Government in all instances.

The U.S. Office of Personnel Management (OPM) previously collected TFUT data from Federal agencies for Fiscal Year (FY) 2019 and published its last TFUT report in October 2020³. This current report analyzes TFUT data for FY 2024. From FY 2019 to 2024, Federal agencies experienced only a 3.92 percent increase in the number of employees represented by labor unions, yet a much more staggering increase (24.32 percent) in the number of TFUT hours used by unions to represent those constituents with a 53.75 percent increase in compensation costs (salary and benefits) for the Federal government. The disproportionate increases between the number of bargaining unit employee and TFUT hours is likely a result of previous administration policies that rescinded the policies of the first President Trump Administration and encouraged collective bargaining, pre-decisional involvement, and labor-management forums; increases in employment costs; and other factors.

Large amounts of official time allocated to agency employees conducting activities on behalf of unions have resulted in widespread diversion of resources from agency mission-critical functions. In many cases, where agency union representatives serve as full-time union officials, agencies are no longer able to rely on employees even for a portion of their duty time, to complete the duties of the positions for which they were hired.

“Official time,” as authorized by [5 U.S.C. § 7131](#), is paid time spent by Federal employees performing representational work for a bargaining unit in lieu of their regularly assigned work.

In other words, the Federal Labor Relations Authority (FLRA) has equated official time to be the same as work time or hours of work.⁴

Agency Reporting Requirements and Public Disclosure and Transparency

On February 27, 2025, OPM directed agencies⁵ to submit a report regarding FY 2024 TFUT data by March 14, 2025 that included the following:

- 1) The purposes for which the agency has authorized the use of taxpayer-funded union time;
- 2) The amounts of time used for each such purpose of taxpayer-funded union time;
- 3) The total number of bargaining unit employees as of September 30, 2024;
- 4) The total value of the free or discounted use of government property for labor organizations or individuals on taxpayer-funded union time;
- 5) Any expenses the agency paid for activities conducted on taxpayer-funded union time;
- 6) The amount of any reimbursement paid by the labor organizations for the use of government property;
- 7) The job title, position description number, official duty station, and total compensation (cost of salary and benefits) of each employee who has used taxpayer-funded union time in the fiscal year; and
- 8) The total number of hours each employee spent on these activities and the proportion of each employee's total paid hours that number represents.

Preventing Unlawful or Unauthorized Expenditures

Each agency is responsible for monitoring the use of taxpayer-funded union time to verify that it is being used only for authorized purposes, and that it is not being used contrary to law, regulation, or their collective bargaining agreements.⁶ While there is no uniform Governmentwide requirement concerning the degree and specificity of records kept for this purpose, OPM provides guidance to agencies to record taxpayer-funded union time by using the following categories: (1) Term Negotiations; (2) Mid-Term Negotiations; (3) Dispute Resolution; and (4) General Labor-Management Relations. In the February 27, 2025 memorandum, OPM directed agencies to report all required data to OPM via a provided template. OPM has relied on each agency to report accurate data to OPM, which is included in this Governmentwide report. We believe this has facilitated greater transparency, accountability, and accuracy. OPM will continue to work with agencies in identifying ways to improve the reporting of TFUT and the reliability of such data.

Fiscal Year 2024 Taxpayer-Funded Union Time Data Call Findings

Based on the data received, in FY 2024 unions represented 1,381,300 non-Postal Federal civil service bargaining unit employees. Agencies⁷ reported that bargaining unit employees spent a total of 3,240,143 hours performing representational duties on taxpayer-funded union time, an increase of 24.32 percent compared to FY 2019. Governmentwide, the number of taxpayer-funded union time hours used per bargaining unit employee on representational matters increased from 1.96 hours during FY 2019 to 2.35 hours in FY 2024.

Taxpayer-Funded Union Time Usage by Bargaining Unit Employees

The following table shows the number of hours agency bargaining unit employees (BUEs) used taxpayer-funded union time during FY 2024 and the proportion of paid time spent on such activities. OPM used the total number of hours employees received pay⁸ compared to the total number for TFUT hours provided by agencies to calculate the overall proportion of time spent on TFUT. The table also shows the total number of bargaining unit employees, Governmentwide, and the change in the number of bargaining unit employees between FY 2019 and FY 2024.

Comparison of Taxpayer-Funded Union Time Hours & Rates to Previous Reporting Year

The following table shows the number of taxpayer-funded union time hours agencies reported and the taxpayer-funded union time rate, with the changes between FY 2019 and FY 2024. The TFUT Rate indicates the number of taxpayer-funded union time hours expended per bargaining unit employee in a fiscal year and allows for comparisons of taxpayer-funded union time usage Governmentwide. The amount of taxpayer-funded union time hours used in FY 2024 was 3,240,143 hours, which is an increase from the 2,606,390 hours reported in FY 2019. The average FY 2024 TFUT rate was 2.35 which is an increase from the FY 2019 TFUT rate of 1.96.

Value of Government Property Usage and Other Expenses, and Agency Reimbursements

Taxpayer-funded non-payroll costs for union activities can also be significant. The following table shows the value of government property (e.g., space, equipment) agencies have provided to labor organizations and any expenses agencies paid in relation to activities conducted on taxpayer-funded union time, such as travel, per diem, equipment, and other expenses, in FY 2024.

Of the 63 agencies who reported data to OPM, only two agencies (DoD and State) received reimbursements for the use of government property, totaling \$16,496.00 for FY 2024. The percentage change in each of these values from the previous reporting year is listed below.

Purposes of Taxpayer-Funded Union Time

The purposes for which taxpayer-funded union time was granted during FY 2024 are grouped under four categories: Term Negotiations, Mid-Term Negotiations, Dispute Resolution, and General Labor-Management Relations. Taxpayer-funded union time usage for General Labor-Management Relations accounted for the greatest share of Governmentwide TFUT hours. Agencies reported 2,542,992.50 hours in the General Labor-Management Relations category, representing over 78 percent of all reported taxpayer-funded union time hours.

Taxpayer-Funded Union Time Compensation Costs

Taxpayer-funded union time compensation costs were provided by 63 of the 67 agencies for FY 2024. OPM requested each agency provide the total compensation costs (salary and benefits) for each bargaining unit employee who used taxpayer-funded union time during FY 2024. Using this measure, the total Governmentwide payroll costs reported to OPM by agencies, including salary and benefits¹⁰, for FY 2024 taxpayer-funded union time hours were \$207,540,736.82 (See [Appendix B](#)). In comparing FY 2019 and FY 2024 data, the cost of taxpayer-funded union time hours increased by 53.75 percent over this 5-year period.

Conclusion¹¹

Agencies reported that, during FY 2024, bargaining unit employees spent a total of 3,240,143 hours performing representational duties on TFUT, an increase of 24.32 percent compared to FY 2019. Governmentwide¹², the number of TFUT hours used per bargaining unit employee on representational matters increased from 1.96 hours in FY 2019 to 2.35 hours during FY 2024.

The estimated total payroll costs, salary and benefits, for employees who used TFUT hours in FY 2024 were \$207,540,737. In comparing FY 2019 and FY 2024 data, the estimated cost of TFUT hours increased significantly over this 5-year period. Like the FY 2019 report, the FY

2024 report on TFUT usage in the Federal Government includes payroll costs and captures a complete accounting of the costs of union activities in the Federal Government. In addition, OPM's report includes the costs to agencies for labor organization use of taxpayer-funded facilities, equipment, and travel expenses for collective bargaining. The total value of government property used by labor organizations was \$28,982,095 and other expenses paid by agencies totaled \$2,507,796 in FY 2024, resulting in a cost of \$31,489,891 to the American taxpayer for the operation of labor organizations.

The total cost to the American taxpayer, provided by the Federal Government, for TFUT and other expenses incurred by labor organizations was \$239,030,628. While costs to the American taxpayer appear to have increased since the last published report, OPM believes opportunities exist for the Federal Government to reduce these costs.

Appendix A – Taxpayer-Funded Union Time Definitions and Terminology

Taxpayer-Funded Union Time (Official Time) means all time, regardless of agency nomenclature, granted to an employee by the agency to perform representational functions under [5 U.S.C. Chapter 71](#) and by collective bargaining agreement when the employee would otherwise be in a duty status.

Taxpayer-Funded Union Time Reporting Categories— agencies are asked to report four categories of taxpayer-funded union time use.

- **Term Negotiations** — this category for reporting taxpayer-funded union time hours refers to time used by union representatives to prepare for and negotiate a basic collective bargaining agreement or its successor.
- **Mid-Term Negotiations** — this category for reporting taxpayer-funded union time hours refers to time used to bargain over issues raised during the life of a term agreement.
- **Dispute Resolution** — this category for reporting taxpayer-funded union time hours refers to time used to file and process grievances up to and including arbitrations and to process appeals of bargaining unit employees to the Federal Labor Relations Authority and, as necessary, to the courts.
- **General Labor-Management Relations** — this category for reporting taxpayer-funded union time hours refers to time used for activities not included in the above three categories.

Representational Functions refers to activities undertaken by employees acting on behalf of the labor organization or fulfilling the organization’s responsibility to represent bargaining unit employees in accordance with 5 U.S.C. Chapter 71 and a collective bargaining agreement.
