**SUBJECT: 2017 COMBINED FEDERAL CAMPAIGN COMPLIANCE
PROGRAM AND AUDIT GUIDE**

The attached Combined Federal Campaign (CFC) Audit Guide (Guide) provides the requirements and guidance for the completion of the audit in accordance with CFC regulations at 5 CFR § 950.105(d)(9). This section requires Principal Combined Fund Organizations (PCFO) to submit to the Local Federal Coordinating Committee (LFCC) an audit of its collections and disbursements for each campaign managed. The audit must be conducted by an independent certified public accountant (IPA) in accordance with generally accepted auditing standards and Office of Personnel Management (OPM) guidance.

Some changes were made to the Guide. These are described in the attached Executive Summary.

The Guide will require:

- An AUP report from an IPA reporting results from its audit of campaign activities from the **2015** campaign; and
- A corrective action plan from the PCFO and LFCC if the IPA AUP report contained findings.
- Electronic transmission of complete pledge database for, at a minimum, campaigns 2011-2015. This should be in either Excel or CSV format.

Due to the cost of converting Excel spreadsheets to be Section 508 compliant, the required schedule templates will no longer be on the CFC website for download. They will be provided to all campaigns via e-mail. Independent Public Accountants should contact the OPM Office of CFC at cfc-compliance@opm.gov or (202) 606-2564 to request the templates be e-mailed to them.

The reports and other supporting schedules must be submitted to the LFCC by August 1, 2017, and forwarded to OPM by September 15, 2017 if sending via hard copy. The due date for electronic submissions is September 30, 2017. Campaigns that do not submit the items to OPM by the due date will be considered non-compliant. Extensions to the due dates noted above will only be approved by OPM under extraordinary circumstances.
