Message from the Acting Director

The U.S. Office of Personnel Management (OPM) is pleased to transmit its annual report to Congress on agencies' use of student loan repayment discretionary authority¹ during calendar year (CY) 2023. Section 5379 of title 5, United States Code, authorizes agencies to establish programs under which they may repay certain types of Federal student loans (including certain student loans that are made through Federal programs or are Federally insured or guaranteed) to recruit or retain highly qualified personnel in exchange for a service commitment from the employee. Agencies are required by 5 U.S.C. 5379(h)(1) to submit to OPM certain data regarding their student loan repayment programs, and OPM is, in turn, required by section 5379(h)(2) to compile the data and submit an annual report to Congress.

During CY 2023, OPM received responses from sixty-two (62) Federal agencies. Thirty-five (35) of these agencies collectively provided 14,294 employees with a total of \$136.8 million in student loan repayment benefits.

¹ OPM regulates the [Federal Student Loan Repayment](#) discretionary authority for agencies at [part 537, title 5, Code of Federal Regulations](#). The Student Loan Repayment Program (SLRP) is often confused with the [U.S. Department of Education's Public Service Loan Forgiveness \(PSLF\) program](#), which is available to Federal, state, local, and tribal government employees and many in the not-for-/non-profit sectors. The programs are distinct from one another; utilize different criteria for eligibility; have separate statutory authorities; and are administered very differently. OPM has no role in the PSLF program.

Executive Summary

Federal agencies that utilize the student loan repayment authority of [section 5379 of title 5, United States Code](#) are required by section 5379(h)(1) to report annually to OPM on their use of student loan repayments during the previous calendar year (CY). Section 5379(h)(2) requires OPM to prepare, and annually submit to Congress, a report containing information provided by agencies that use this human capital authority. On February 12, 2024, OPM issued a memorandum ([CPM 2024-04 Request for CY 2023 Data on Student Loan Repayments](#)) requesting agency reports on the use of student loan repayment during CY 2023. In this memorandum, OPM also invited agencies to provide additional details on their experiences in administering their [student loan repayment programs](#).

Overall, for CY 2023, there were sixty-two (62) Federal agencies that reported, with thirty-five (35) providing 14,294 employees with student loan repayment benefits totaling \$136.8 million. The average student loan repayment benefit in CY 2023 was \$9,567.83.

During CY 2023, the majority of student loan repayment benefits was provided by thirteen (13) agencies. All thirteen (13) paid over \$1 million in SLRP benefits.

These agencies also represent slightly over 97 percent of the total SLRP funding paid and the total number of recipients for CY 2023 Government-wide. Overall, these agencies provided 13,881 employees with \$133.3 million in SLRP benefits. The combined total of the remaining twenty-two (22) agencies provided 413 employees with \$3.5 million in SLRP benefits.

OPM strongly encourages agencies to establish metrics that can demonstrate the value of using student loan repayment and other discretionary incentives commensurate with the benefits gained. For example, an agency can track the retention rate of student loan repayment recipients over time and compare it to the retention rate for employees who do not receive student loan repayment benefits. An agency can also survey job candidates and hiring managers before and after implementation of this human capital tool.

I. Background

[Section 5379 of title 5, United States Code](#) (U.S.C.), authorizes agencies to establish a program under which they may repay certain types of Federal student loans (including certain student loans that are made through Federal programs or are Federally insured, or guaranteed) as an incentive to recruit or retain highly qualified personnel. Under law, agencies may make payments to a loan holder of up to \$10,000 for an employee in a calendar year, up to an aggregate maximum of \$60,000 for any one employee. In return, the employee must sign an agreement to remain in the service of the paying agency for at least 3 years. If the employee separates voluntarily or is separated involuntarily for misconduct, unacceptable performance, or a negative suitability determination under [part 731 of title 5, Code of Federal Regulations](#) (CFR) before fulfilling the service agreement, they must reimburse the paying agency for all student loan repayment benefits received. 5 U.S.C. 5379(h)(1), requires agencies to report annually to OPM on their use of student loan repayments. The law also directs OPM to prepare and submit annually to Congress a report containing the following information:

- Number of Federal employees selected to receive student loan repayment benefits,
- Job classifications of the recipients, and
- The cost to the Federal Government of providing the student loan repayment benefits.

II. OPM's Annual Request to Agencies for SLRP Reports and Agency Responses

On February 12, 2024, OPM issued a memorandum for Human Resources Directors ([CPM 2024-04 Request for CY 2023 Data on Student Loan Repayments](#)) requesting that agencies submit their annual written reports to OPM on their use of SLRP by March 31, 2024.

In accordance with [5 CFR 537.110\(b\)](#), the memorandum required agencies to send OPM information on their use of the SLRP during CY 2023. OPM received responses from sixty-two (62) departments and independent agencies: positive responses from thirty-five (35) agencies that used the authority and negative responses from twenty-seven (27) agencies that did not use this authority. reporting agencies.

In CY 2023, thirty-five (35) Federal agencies that submitted data provided 14,294 employees with a total of \$136,762,561.85 in SLRP benefits. For more detailed information by agency, see [Appendix 2](#).

III. Agencies Providing SLRP Benefits Greater than \$1 Million

As referenced above, in CY 2023, thirteen (13) agencies made the most extensive use of student loan repayments. These agencies represent slightly over 97 percent of the total SLRP funding paid and the total number of recipients for CY 2023 Government-wide. Overall, these agencies provided 13,881 employees with \$133,253,750.83 million in SLRP benefits. The following table provides a comparison of the total number of SLRP recipients at each agency and the total amount of SLRP benefits paid, in rank order by total SLRP benefits paid. Following the table below, a high-level description is provided for each of the thirteen (13) agencies with the total number of employees receiving benefits, agency costs, and their top occupations.

The **Department of the Treasury (Treasury)** during CY 2023 reported providing 4,413 employees with student loan repayments, at a cost of \$41.2 million. At Treasury, Contact Representatives in the 0962 occupational series had the greatest number of employees receiving student loan repayments at 1,384. They were followed by 631 in the 0512 Internal Revenue Agent series; 511 in the 0592 Tax Examining series; 368 in the 2210 Information Technology Management series; 290 in the 0501 Financial Administration and Program series; and 243 in the 1169 Internal Revenue Officer series.

The **Department of Veterans Affairs (VA)** during CY 2023 reported providing 1,294 employees with student loan repayments, at a cost of \$20.3 million. At the VA, Social Work in the 0185 occupational series had the greatest number of employees receiving student loan repayments at 244.

The **Department of Defense (DOD)** during CY 2023 reported providing 2,171 employees with student loan repayments, at a cost of \$18.8 million. At DOD, professionals in the 1102 Contracting occupational series had the greatest number of employees at 411.

The **Department of Justice (DOJ)** during CY 2023 reported providing 1,523 employees with student loan repayments, at a cost of \$13.6 million. At DOJ, Special Agents in the occupational series 1811 had the greatest number of employees receiving student loan repayments at 236.

The **Department of Health and Human Services (HHS)** during CY 2023 reported providing 1,418 employees with student loan repayments, at a cost of \$12.5 million. At HHS, professionals in Consumer Safety Officers in the 0696 occupational series had the greatest number of employees receiving student loan repayments at 204.

The **Department of State (DOS)** during CY 2023 reported providing 1,096 employees with student loan repayments, at a cost of \$11.2 million. At DOS, the Foreign Affairs occupational series 0130 had the greatest number of employees receiving student loan repayments at 163. They were followed by the Passport and Visa Examining series 0967 at 158 employees and the 0343 Management and Program Analysis series at 127 employees.

The **Department of Homeland Security (DHS)** during CY 2023 reported providing 500 employees with student loan repayments, at a cost of \$4.5 million. At DHS, the 1811

occupational series for Criminal Investigation had the greatest number of employees receiving student loan repayments at 249.

The **Department of Agriculture (USDA)** during CY 2023 reported providing 456 employees with student loan repayments, at a cost of \$4.2 million. At USDA, the Agricultural Loan series 1165 had the greatest number of employees receiving student loan repayments at 154 employees. They were followed by Program Technicians in the 1101 occupational series at 62, and the Supervisory Veterinary Medical Officer series 0701 at 57 employees.

The **Agency for International Development (AID)** during CY 2023 reported providing 184 employees with student loan repayments, at a cost of \$1.7 million. At AID, Contracting professionals in the 1102 occupational series had the greatest number of employees receiving student loan repayments at 43. They were followed by 34 employees in the Management and Program Analysis series 0343.

The **Department of Housing and Urban Development (HUD)** during CY 2023 reported providing 392 employees with student loan repayments, at a cost of \$1.6 million. At HUD, the Management and Program Analysis 0343 occupational series had the greatest number of employees receiving student loan repayments at 59. They were followed by Equal Opportunity Compliance Specialists in the 0360 series at 26.

The **Department of Energy (DOE)** during CY 2023 reported providing 134 employees with student loan repayments, at a cost of \$1.3 million. At DOE, the Management and Program Analysis 0343 occupational series had the greatest number of employees receiving student loan repayments at 24.

The **Department of the Interior (DOI)** during CY 2023 reported providing 146 employees with student loan repayments, at a cost of \$1.2 million. At DOI, Petroleum Engineers in the 0881 occupational series had the greatest number of employees receiving student loan repayments at 16.

The **Federal Energy Regulatory Commission (FERC)** during CY 2023 reported providing 154 employees with student loan repayments, at a cost of \$1.2 million. At FERC, the General Attorney 0905 occupational series had the greatest number of employees receiving student loan repayments at 52.

Additional Departments and Agencies. Besides the above top thirteen (13) agencies, five (5) other agencies spent more than \$200,000 in 2023 to support their student loan repayment programs. (See Appendix 2. Details for Reporting Agencies for CY 2023 for detailed agency reports.)

IV. Conclusion

Agencies must ensure that the costs of using student loan repayments and other discretionary benefits are commensurate with the benefits gained. The use of discretionary tools such as student loan repayments requires close monitoring and evaluation as part of an agency's overall human capital expenditure. During CY 2023, OPM received data responses from sixty-two (62) Federal agencies. Thirty-five (35) of these agencies collectively provided 14,294 employees with a total of \$136,762,561.85 in student loan repayment benefits. OPM will continue to work with agencies to assist them in strategically using student loan repayment benefits, as well as other existing recruitment and retention tools, as necessary, to attract and retain employees to support agency mission and program needs.
