## SUBJECT: Federal Employees' Group Life Insurance Revision of RI 76-21 (FEGLI Booklet)

Date of Revision

The revised booklet is dated April 1995.

Purpose of Revision

The booklet has been revised to update the address of the Office of Federal Employees' Group Life Insurance (OFEGLI), to add OFEGLI's toll-free phone number, to reflect the use of the money market option account, to add information on assignment of life insurance and living benefits, to add information on the election of Optional insurance upon divorce or death of a spouse, and to reflect the new procedures for enrollment reconsiderations.

When and How Available The revised RI 76-21 is available this month. Initially, agencies should not request the revised booklet. OFEGLI will automatically send a supply of the booklet (equal to approximately 110% of the population at each address) to each agency shipping point used during the 1994 FEHB open season. Shipment has already begun; final shipments should be received by the first week in May.

In the future, booklets must be ordered by the agency headquarters officer who normally requisitions other forms. That person may obtain the booklet by contacting OPM, Retirement and Insurance Service, Forms Analysis and Design, Room 4H28, 1900 E Street NW, Washington, DC, 20415, or fax 202-606-0910.

Requests will only be honored from agency headquarters staff.

Large Print Version of the Booklet A large print version, RI 76-24, is also available for the visually impaired. Initially, agencies should not request the large print version. OFEGLI will automatically send a supply of the large print version to the same shipping points and in the same quantities as the large print FEHB Guide (RI 70-10) used during the 1994 FEHB open season.

In the future - and for agencies whose needs have changed since the last FEHB open season - large print booklets must be ordered by agency headquarters staff at the address given on the previous page.

Audio Tapes for the Visually Impaired Attached is an order form for agencies to use in ordering audio tapes of RI 76-21 for their visually impaired employees. OFEGLI will accept orders for the audio tapes only from agency headquarters Insurance Officers.

What Are Agencies Supposed to Do with the Booklets? Agencies are required to distribute the revised FEGLI booklet to <u>all</u> employees, not just those enrolled in the Program. This includes sending copies to employees who are on leave without pay.
