

Accessing HCaTS

HCaTS Direct: After your Contracting Officer attends mandatory training, GSA will issue a Delegation of Procurement Authority to the ordering contracting officer, who can then award a task order through the contracts. OPM is available to provide complimentary scope advisory reviews for customer agencies.

HCaTS Assisted Services: OPM — supported by GSA's contracting expertise — performs the acquisition on your behalf and provides pre- and post-award support.
