Suitability Action Procedures for Suitability Adjudicators – Payment Form

Each trainee must complete a separate form. Tuition is \$998 per student, which includes all educational services and materials.

When paying by Intra-Governmental Payment and Collection (IPAC), an Interagency Agreement (IAA) is required if sending three or more trainees. When paying by Government Purchase Card (GPC), an IAA is preferred if sending three or more trainees and payment can be processed in one transaction (versus separate transactions).
