# **Driving Directions and Parking**

**From Virginia via I-395 North:** Take Exit 8B (Virginia 27/Washington Blvd. toward Rosslyn). Merge onto VA-27 E/S Washington Blvd. and continue straight. Take a slight right onto Arlington Memorial Bridge. Stay left onto Lincoln Memorial Cir., NW. Turn left on 23<sup>rd</sup> Street, NW. Turn right onto E Street, NW.

**From Virginia via I-66 East:** Take E Street/Interstate 66 E exit on the left. Keep right and follow signs for E Street. Turn left onto 20<sup>th</sup> Street, NW. Turn right on E Street, NW.

**From Maryland via I-495:** Take I-495 S. Take Exit 43 for George Washington Memorial Pkwy. Take exit onto I-66 E toward US-50 E/Washington. Keep right and follow signs for E Street. Turn left onto 20<sup>th</sup> Street, NW. Turn right on E Street, NW.

Parking is not available on GSA's premises. There is street parking is available and area garages are available at cost. The nearest parking garage is on 18th street, between G & F Streets. Parking can fill up quickly, and finding a spot (street or garage) after 9:00 am can be a challenge – please allow enough time or take the Metro (see below). ## **Metro Rail and Bus Directions**

**From Farragut West (Blue, Orange, or Silver Line**): Walk south down 18<sup>th</sup> Street, NW. Turn Right onto E Street and continue down to the building doors immediately after the entrance to Greenberry's Coffee Co. (*see E Street Entrance section below*).

**From Farragut North (Red Line):** Walk down Connecticut Ave., NW toward K Street, NW. Continue on to 17<sup>th</sup> Street, NW. Turn Right onto E Street and continue down to the building doors immediately after the entrance to Greenberry's Coffee Co. (*see E Street Entrance section below*).

There are number of **bus stops** near the GSA Central Office building; to see what bus lines make stops near the building, please refer to <u>http://www.wmata.com/</u>.

Metro is currently operating under the SafeTrack plan to update metro rail lines. To obtain the most up-to-date information regarding SafeTrack, and see if your commute to GSA will be impacted, please refer to <u>http://www.wmata.com/rail/safetrack.cfm</u>.

## **Entering GSA (Central Office) Building: E Street Entrance**

Attendees will need to enter the GSA building through the E Street Entrance -- the entrance is between Greenberry's Coffee Co. and California Tortilla. If you are coming down 17th Street, NW, turn Right onto E Street and continue down to the building doors immediately after the entrance to Greenberry's Coffee Co. Attendees will need their Federal employee badge to get into the building.

# **Check-In**

Once attendees have cleared through building security, there will be a guide and signs to direct them to the atrium. The registration table will be located in the atrium, and attendees will be able to check-in and obtain their conference badge and information. Registration check-in will be open from **7:30am to 8:30am**.
